PUMPING FOR CLEAR WATER

City Wells Supply Plenty of Water But Pumps are Still Bringing up Sand

Although there is an abundance of water in the pipes the continuous pumping has failed to clear up the water in the new city wells. There is nothing but clean water sand brought up and the water appears to be of an excellent quality, and it is hoped and expected that plenty of pumping will eventually clear the water.

The council committee has completed a diagram of the mains as they are to be laid and it covers the whole of the incorporated village with the exception of the outlying territory.

A main will be laid the whole length of Grand River avenue from the cemetery on the west to the D. U. R. power house on the east. On Division street it will be laid from the John Collins corner to Shiawassee street. On Shiawassee street from Pangborns east to the M. E. church and from there south to Thomas street, east on Thomas to Cass and south to Grand River avenue. Another will run on Rogers street and connections will be made on all cross streets and, in fact, as stated, service will be given to every house in the village with the exception of the farms that are so far out that the expense makes it prohibitive.

However, the council has agreed that if any of those living without the zone of the mains as contemplated desire to do so they can advance to the village the price of the pipe and it will be laid to their places. The condition under which it will be done is that the village will refund the money so advanced in four equal annual payments, beginning next year. The village to be to no expense for hydrants in this case and to pay no interest on the money so advanced.

Governor Warner has signified his intention to take advantage of this offer and will advance the money necessary to have the pipe laid from Collins' corner to his farm buildings.

FARMER WAYLaid ON WAY HOME

Charles Klett Murderously Assaulted Near Five Points. Harry Spinks Arrested on Suspicion

Charles Klett, a farmer living north of the Volney Smith's corners, was waylaid by a thug last Friday night and only escaped death, seemingly, by a miracle. He had been to Detroit with a load of produce and was on his way home with a load of mill feed when he was attacked just west of Five Points.

The villain climbed on the load from the rear, unnoticed by Mr. Klett, and began clubbing him over the head with a heavy piece of flooring. Blow after blow was rained on his head, but he rolled off the load before he was struck unconscious and sought escape in flight. Running to a nearby farm house he gave the alarm and a telephone to Redford started Deputy Sheriff Willmarth with several others out on the trail. They drove towards Five Points but when along by Grand Lawn met a young man. After passing him they turned about and drove back to interview him, but failed to get sight of him. Then turning around again, they started west, but soon met the party they were looking for and placed him under arrest. It proved to be Harry Spinks, a young man of Northville, with an unsavory past record. He was taken before Mr. Klett, but as the assault was made in the dark, and as the victim had no opportunity to see his assailant, he was, of course, unable to identify him. He said, however, that the young man had asked to ride with him when he was at Redford, but owing to his heavy load he was unable to accommodate him.

Spinks was kept over night in the village jail and closely questioned, but, although he told conflicting and unreasonable stories, he was released in the morning. However, further investigation by the deputies lead to his arrest again and he was taken to Detroit for examination.

Dr. Tupper was called to attend Mr. Klett and found many bad scalp wounds and many other bruises on his head and shoulders. Mr. Klett is able to be about, but suffers considerably from his injuries.

He was arraigned and held for examination next week.
