BIDS WANTED

For a concrete arch bridge to be built at Tibbits, near the town line in the township of Farmington. Bridge to have 12 foot span, 8 feet in height; 16 foot roadway with concrete rails three feet in height; north wings 8 feet, south wings 6 feet; foundation to be 3 ft. thick and to extend to solid foundation or not less than two feet below bed of stream; the arch is to be 3 feet at the base and 10 in. at the top; the wings to be two feet at the base and battered to one foot at the top and deep enough to be below the frost.

The bridge to be reinforced with 3-4 in corrugated steel bars not more than one foot apart lengthwise and crosswise wings to be tied to the abutments with corrugated bars every foot in height. The concrete to be composed of the best portland cement and clean, sharp gravel in the proportion of four to one in the arch and five to one in the abutments and guaranteed to carry fifteen tons in weight. Abutments and concrete floor for five steel bridges: 18 in. base; 12 in. top; will average 5 ft. from bed of stream; reinforced with 3-4 corrugated steel bars every foot in height.
