# **Remember Mother's** Day in a different way

This year, perhaps more than any other in history, it's important for us to remember how and why Mother's Day began. It's important to remember the intent of the woman who first brought it to America, Julia Ward Howe.

Because all Mrs. Howe really wanted was what most every other mother in America wants right now; peace.

A writer, poet and author of the Battle Hymn of the Republic, Mrs. Howe co-founded the New England Women's Club which eventually became the American Woman Suffrage Association. A fierce patriot and women's advocate, she also worked for the cause of peace around the world.

Saddened by the barbarism she perceived in the France-Prussian War, Mrs. Howe wrote the following in her reminisces:

"The question forced itself upon me. Why do not the mothers of mankind interfere in these matters, to prevent the waste of that human life of which they alone bear and know the cost?...The august dignity of motherhood and its terrible responsibilities now appeared to me in a new aspect, and I could think of no better way of expressing my sense of these than that of sending forth an appeal to womanhood throughout the world, which I then and there composed."

Her appeal called on women to solemnly take counsel with each other as the means whereby the great human family can live in peace, and

each bearing after her own time the sacred impress, not of Caesar, but of God."

God."
Even today, these words ring true.
The mothers who gave birth to fatherless children after Sept. 11 understand all toe well the terrible cost of war. The mothers whose sons have died in helicopter crashes and explosions, the mother whose husbands have been sent to places where lives are lost in conflict

Gold and silver star mothers, who had nothing left of the sons they lost in wars past but a banner to hang from the window, understand.
Howds "Nother's Day" and the national observance intended by Anna Jarvis of Philadelphia have long been lost to commercialism. # Businesses need help

# Time to clear up rules on liquor licenses

Given this state's fierce loyalty to home rule, Michigan's liquor license laws are a bit of a mystery – one we believe it's time to resolve. The problem, some local government

The problem, some local government officials say, is that a change in the flaw two years ago allows businesses that sell liquor to put their license into escrew when they close up shop. They can hold the license until they get back on their feet or they can sell it, to anyone within their home county.

it, to anyone within their home county.

Yes, cities have to recommend approval of the transfer – and the Liquor Control Commission relies heavily on their determinations – but what local official in his or her right mind would say no to a new business with a decent track record?

No open licenses in Livonia? Check out one of eight escrowed by businesses currently listed on the Liquor Control Commission's Web site. Interested in opening a bar in Redford Township, but can't get a new license? Ten from that are in escrow.

And if you can't make a deal there, look elsewhere in Wayne County.

Canton Township, Plymouth Township and Westland are also among are cities that have licenses on the current escrow light, licenses that are counted

cities that have licenses on the current escrow list, licenses that are counted against their quota.

And there's the rub. Even though the number of liquor licenses allowed in each city or township is based on population, there may actually be fewer licenses held than are allowed.

In Farmington Hills, for example, the city's growth over the past 10 years netted five additional liquor licenses. But Farmington Hills has lost six Class C liquor licenses through the escrew process.

"We don't have the number of licenses

we should have, based on our popula-tion," anid City Clerk Kathryn Dornan.
"The council's concern is if that's how they're going to distribute them ... something needs to be changed."
We couldn't agree more. If the state doesn't want to issue more licenses, then it should at least even the playing field by counting them fairly, allowing a license for each gained.
And while they're at it, maybe law-makers ought to carefully examine how these valuable permissions are being handled in a competitive market.



I am a former student of OLS. In my art class, we would paint pictures of religious icons and hang them up in the school. Shared time would there fore negate any religious projects in art class, and would defeat the pur-pose of sending our children to a Catholic school.

Religion also played a part in my music class, where we would sing church songs and songs about Christian holidays such as Christmas. This was one my most favorite times at school, and to take this away from the children would be a crime.

The children will not get a Catholic education in almost half of their classes. Why spend \$3,000 a year per child when one can send them to a public school for the same education for free? Also, leaving OLS is not an option for most parents. For example, St. Fabian is full and has only a few spots open for incoming students. To me, shared time is just a way of saving a few extra pennies, and at the cost of saving money, we are cutting our children short of a Catholic cleuaction.

He also said, I nave intuitize a decision to move forward with a shared-time program for Our Lady of Sorrows School with an implementation date for the fall of 2003. In other words, regardless of the majority of the people against it, he is going to make his own

Tuition is more than sufficient to cover the cost, Magr. Hurley has made it clear that shared-time has worked in other schools, but he has failed to also make it clear that it has not worked in other schools, such as Guardian Angels in Clawson.

To people who are in support of shared-time, this may be a "win-win" situation financially, but to the parents and students, those who are affected, it is not.

## ■ Walk facts missing

Ivo been reading articles about the Avon Bronst Cancer 3-Day walk in the newspapers lately. There are some very important facts missing from these articles, which everyone thinking of donating to this event should know.

1. This walk event is run by a FOR-profit company, called Pallotta Team-Works, You can download a full financial disclosure at their OTHER Web site, pallottateamworks.com (which is

site, pallottateamworks.com (which is not linked from their bethepcople.com website, that advertises their events). 2. "MyNoedle.org" is a non-profit

resource for charity organizations that thoroughly researched Pallotta Teamworks in January, 2002. They reported several misleading practices by Pallotta Teamworks, including not telling donors what percentage of their donation is actually going to charity, versus to Pallotta.

donors what percentage of their dona-tion is actually going to charity, versus to Pallotta.

3. As for-profit company, Pallotta that forwarded only 60% of the rev-enues raised since 1994 to charities (for AIDS, breast cancer and child abuse charities, through various spo-cial evente). Pallotta charges charities a flat fee to run events, plus receives a certain percentage of funds raised.
This means Pallotta will never take a loss for a less-than-successful event. but the charities are not guaranteed

any income at all.

4. If a registered participant does not raise the minimum required don tions (30 percent of the participants fail to meet this minimum), they are fail to meet this minimum), they are not allowed to participate, and all donations are non-refundable. With the issues surrounding how

donations are non-refundable.
With the issues surrounding how charities used money raised postSeptember 11th, the public has made it known that it is concerned about how charitable donations are being spent. Events like the Avon 3-Day do great things to raise public awareness, and raise funds to help support the cause, but it is irresponsible not to be forthcoming about who receives each dollar donated.

There are other breast cancer related charities in this area that are worth supporting (with higher percentages of dollars raised going toward the overall mission). I encourage everyone to make educated decisions about where you invest your donations.
