Attached to the measure were amendments for the repeal of the Canadian reciprocity law and the fixing of a 32 per ton tariff on priot paper, and for the establishment of a permanent non-partiant tariff commission.

The United States senate defeated the Cummins wool tarfff bill by 34 to 32, adopted the Fenrose compromises measure and finally passed the La Foliatie wool bill of 1911 by a vote of 46 to 20, the Democrats and insurgents voting together.
