Commission Will Learn Road Cost At Next Meeting

City Is Experimenting To Find Most Economical Surface For Roads

Final costs of the application of a semi-hard surface on two blocks of Farmington Road from Grand River to Shawwassee are being compiled and will be presented to Farmington City Commission at its next meeting.

This kind of road surfacing, consisting of about two and a half inches of sand, gravel and heavy asphalt-like oil is new to Farmington streets and was done primarily as an experiment. If it proves successful, it is planned to surface other Farmington streets in the same manner.

This is the third kind of semi-hard surfacing the city has done in an attempt to find the best and most economical one. The first kind consisted of only a thin coat of gravel mixed with oil on the old dirt road bed. The second, which was applied on about two blocks of road between the Baptist church and Warner, was heavier and was applied to a gravel bed.

Experiences in other municipalities have shown that the kind just completed lasts as long as six years with little or no repairing.

Justice Court Deals With Three For Motor Violations

Farmington-Rink Seems Assured For Next Season

Rouge River Will Be Source of Water Supply For Rink

Ice skating on a rink of more than an acre in area will be a reality in Farmington next winter, according to plans outlined by Commissioner Emory Hutton this week. Started as a GWA project some time ago but lately discontinued because of more pressing work, the site soon will be the scene of activity again.

The rink will be located back of the high school building on River Rouge, which will be the source of water supply. Construction of a dam on the river and excavation of hundreds of yards of earth are the main tasks to be done to complete the project, although some dynamiting will be required to clean the bed of the rink of stumps and other debris.

The earth work will be constructed to provide for a depth of two and one-half feet of water. The filling of the rink will be natural and will save the city at least \$100 a year for water and labor, it was pointed out, and the results will be far more satisfactory.

Fulfillment of plans for the pond will be welcomed by Farmington people, young and old alike. In the past it has been necessary to do what skating that has been done on neighboring lakes which have not been safe at all times. The Farmington rink will not only be safe but easily accessible.

The second improvement through CWA in the same locality is the construction of a new bridge leading to the athletic field.

Hogle Is Named To Direct Home Improving Work

Will Direct Local Survey of Employment and Building Possibilities

Carl G. Hogle, of the Farmington Lumber Co., received notification this week that he has been appointed chairman of a survey committee for the Farmington area. Mr. Hogle becomes part of an organization designed to bring every community in step with the national recovery program.

Sponsored by the National Federation of Builders Supply Associations, the plan will attempt to augment the national recovery program by a survey of the unemployment situation in each locality and relieve it as much as possible by securing federal legislation for the release of funds to open up a building program.

Make National Survey

The organization with which Mr. Hogle has become affiliated will attempt to present to the President of the United States a national survey and a definite and practicable program for the relief of unemployed artisans, mechanics and laborers.

A complete list of all home owners deemed eligible for modernization and new home construction will be compiled as well as a detailed study of the unemployment situation in each community.

Appointed for Leadership

The letter of appointment to Mr. Hogle follows:

"In recognition of your loyal support of the program of President Roosevelt, and your adherence to the provisions of the Code of Fair Competition for the Builders Supply Industry, and, further, in the belief that your reputation in your community and your leadership will command the support of all groups interested in Local and National Recovery, through the re-employment of local artisans, mechanics and laborers, and the inauguration of the Modernization and Housing Program proposed by the President, I have the honor of appointing you organizer of the Recovery Clinic designed to bring your community in step with the national march to prosperity, which will permit our industry to present to the President a national survey and a definite and practicable program, as set forth in the telegram to President Roosevelt, copy of which is herewith incorporated.

UNUSUAL CONCERTS GIVEN BI-WEEKLY AT PARKVIEW PARK

Twilight concerts are being held each Sunday and Wednesday at the Parkview singing tower in Parkview Memorial Park on Five Mile Road at 7:30 p. m. They are free to the public.

A complete installation of an unusual group of musical instruments, the third installation in the world, provides the music. This group includes a complete pipe organ, cathedral chimes, vibraphone, physarmonica and concert harp, all of which may be played either manually or by mechanical reproduction. There is also special equipment for concerts with stringed instruments, vocal and radio programs.

These programs originate in a building some distance from the singing tower, from which the sound is electrically amplified over the park, providing clear reception for all attending.
