## Annual School Report

OF SCHOOL DISTRICT NO. 6 FARMINGTON-TOWNSHIP

Mr. Smith nominated by Mrs. Pink. Supported by Mr. Newman. Mr. Smith was unanimously elected.

Moved by Mr. Newman the secretary write Mr. Erwin (who was not present at the meeting) a letter of thanks for housing the bus. Supported by Mr. Pink. Carried. Moved by Mr. Weirich, the School District pay full tuition based on Farmington rates. Supported by Mr. Newman. Carried.

Moved by Mr. Wilkinson we have a nine month school. Support by Mr. Smith. Carried.

Moved by Mr. Newman, supported by Mr. McCullough, that we adjourn. Carried.
