

# Leading Musicians Will Take Part In Six Concerts For U. of M. May Festival

For its 45th annual May Festival the University of Michigan Musical Society will present an elaborate series of six concerts in Hill Auditorium, Ann Arbor, May 11, 12, 13 and 14. The Philadelphia Symphony Orchestra under Eugene Ormandy will participate in all of the performances, while the University Choral Union will be heard in presentations of Bachmannoff's "Belts," set to Edgar Allan Poe's "immortal poem," and Bizet's "Carmen." The Young People's Festival Chorus will present the world premiere of "Paul Bunyan" by Dorothy James.

More than a dozen internationally famous soloists will be heard, including Nino Martin, Marjorie Lawrence, Bruna Castagna, Richard Bonelli, Hilda Burke, Giovanni Marinelli and Chase Baromeo of the Metropolitan Opera Association; Marian Anderson, American Negro performer; Arthur Hackett, well-known University of Michigan tenor; Agnes Davis, distinguished American oratorio singer, and Hardin Van Deusen, also of the University of Michigan; as well as Albert Spalding, America's distinguished violin virtuoso; and Artur Rubinstein, the dynamic Polish pianist.

## PHONE CALL WINS STUDENTS B'S AND PROF'S APPROVAL

A telephone call recently brought B's to five Harvard students on a geography assignment, and the congratulations of their professor for their ingenuity.

The students, all sophomores, had been assigned to ascertain the different residential districts of the city of Greenville, N. C., its principal products, and the location of plantations. For hours they worked over the task. They referred to book after book in the University Library, but they could not seem to locate the information they needed.

Finally, in desperation, they called the Mayor of Greenville by telephone. He was very glad to answer all of their questions, and as a result, the five students, as a small expedition, received good marks for their efforts in Prof. Harold Kemp's Geography class.

## Question Box

Editor's Note: This is the third in a series of questions and answers on job insurance in Michigan. This installment answers some of the questions being asked by employers covered by the Michigan unemployment compensation law. Readers of the Enterprise are invited to submit their questions either to this newspaper or to the Michigan Unemployment Compensation Commission, Information Service, 315 Fox Building, Detroit.

Q. What types of personal services are covered by the Michigan Unemployment Compensation Law?

A. Coverage is compulsory to all but a few types of employment, like agriculture, maritime, domestic servant in private homes, employment for non-profit charitable, financial and educational units are exempted.

Q. What size employing entities are exempted under the law?

A. Firms employing less than the required eight workers during

some part of 20 different calendar weeks of the calendar year.

Q. Does that mean that those individuals who work for such entities are not entitled to compensation payments when and if unemployed?

A. Workers for a firm employing less than the required eight or whose services are in exempt employment cannot receive compensation payments, but such unemployed worker may use the job finding services of the Michigan State Employment Service.

Q. How many employing entities who have less than eight workers effect ultimate benefit payments to their employees when they become unemployed?

A. By electing to become subject to the law. This may be accomplished by filing with the commission a request to so elect.

Q. If an employer should fail to pay his contributions, would his workers be disqualified for benefit purposes?

A. No. Such worker would be entitled to benefit payments, if unemployed and if he can meet the other eligibility conditions.

Q. May an employer deduct any part of his contributions from his worker's wages?

A. No. The act specifically prohibits such deduction.

Q. If a worker had regularly

earned \$10 a week up to July 1st, the date benefit claims will be accepted, what would he receive if unemployed after that time?

A. He would receive the maximum of \$16 a week, if he met all other eligibility conditions.

Q. Will benefit payments begin immediately upon a worker's becoming unemployed?

A. No. The act requires a three week waiting period and an additional qualifying week of unemployment. First benefit payments may be made after the expiration of the aforesaid four week period.

Q. May unemployment due to sickness be counted in the waiting period?

A. No. Unemployment resulting from sickness or other physical inability to work may not be credited against the waiting period not utilized as unemployment for which benefits may be received.

Q. Will the eligible unemployed worker receive compensation during the entire period of his unemployment, after the required waiting period?

A. No. The worker may not draw benefits for longer than 16 weeks during the full calendar year which begins with the first week for which such worker receives benefits.

The next installment will answer the questions of the employers.
