Honorable City Commission City of Farmington

Due to the action of the Supreme Court in the case of the People v. Hall, reported in the Michigan Reporter, known as 290 Michigan, page 15, in holding Act 228 of the Public Acts of 1935 unconstitutional, and as a result of said decision, an emergency exists in the City of Farmington, and it being necessary to safeguard life and property therein, I, Leo F. Gildmeister, Mayor of the City

of Farmington, request the City Commission to give immediate effect to Electrical Ordinance No. C-19-40.

Motion made by Hamlin and supported by Otis that the City Clerk be instructed to write the City of Detroit asking them if they would be willing to change the street named Farmington Road within the City of Detroit to Silvasvase so it will not conflict with a street in the City of Farmington named Farmington Road.

The regular meeting of March 11, 1940 adjourned to March 13 called to order by the Mayor at 8:29 p. m.

Resolved: that the Ordinance No. C 20-40 and franchise of The Detroit Edison Co., as read, to be adopted, subject, however, to confirmation by a vote of the electors of the City of Farmington, Oakland County, Michigan.

Motion made by Hamlin and supported by Hutton that the City Commission of the City of Farmington, do a special election for the adoption or rejection of Ordinance No. C 20-40 on Monday, April 29, 1940 granting a franchise to The Detroit Edison Co., a New York Corporation, its successors and Corporation, to construct, maintain and operate in the public streets, highways, alleys and other public places in the City of Farmington, Oakland County, Michigan, all needful and proper poles, towers, masts, wires, pipes, conduits, and other apparatus requisite for the transmission and distribution of electricity for public and private use.
