

NINE COUNTIES TO HOLD TOURIST WEEK MEETINGS

In addition to the meetings to be held in Detroit and the metropolitan area, twenty-five meetings devoted to Know Michigan Tourist Week will be held in nine counties of Southeastern Michigan from April 14 to April 21. Tourist authorities will give talks before each of the meetings calculated to educate Michigan business men to the value of the state's second industry, which brings into Michigan \$315,000,000 every year.

Don R. Westendorf, President of the Southeastern Michigan Tourist and Publicity Association, points out that advertising plans are now being made throughout all Michigan by the four state tourist associations to bring over 12,000,000 visitors to the state during 1940. "And to do this," he says, "We need as much cooperation from Michigan business and industry as we can get. The state conservation department and the state highway department and public officials are doing their share to make Michigan attractive and convenient for its visitors. Now, it who

is up to business men and the public to do the rest."

The campaign thus far has been especially active in Washtenaw County where eight pep meetings will be held next week and in Wayne County and Detroit which will sponsor a drive to raise \$100,000 to bring conventions and tourists there and into Southeastern Michigan during the coming year.

Stanley G. Waltz, of Ann Arbor, and Chester Manning, of Ypsilanti, who are co-chairmen for the Know Michigan Tourist Week in Washtenaw County, feel highly elated over the manner in which the business men, public officials and service clubs of their district have carried out their assignments.

Southern strawberry growers are getting the services of a Michigan State College specialist in horticulture, H. A. Cardinell, who left the campus recently for Hammond, La. For a month Mr. Cardinell will work with the southern growers attempting to devise better methods of precooling strawberries for shipment to northern consumers.

Michigan normally consumes its own strawberries around July 4, but at this time of the year the supply is from the south. The Hamden district, for instance, annually ships from 3,000 to 5,000 cartons, rolled north in heavy refrigerator cars and even in solid trainloads.

Severe cold weather in the south delayed the berry crop a month later than normal this year. According to Cardinell, the first full carton was shipped just recently.

MARRIAGE PROOF IS NECESSARY TO GET CLAIMS

Marriage certificates have taken on added importance in connection with Federal Old-Age and Survivors Insurance, according to Richard H. Hendrick, manager of the Social Security Board's field office at Pontiac. Knowing where to put her husband on her insurance papers, he said, he will be able to begin getting her monthly insurance checks from the Federal Government quickly.

Hendrick explained that the new system which went into effect last January provides survivors insurance for widows and children of workers who die, as well as old-age insurance for qualified wage-earners and their wives after age 65. Claims for insurance are now being received, he said, from the widows of men who have died since the first of this year when the new plan went into operation. Experience with these claims has shown that the delay in producing proof of marriage may hold up payment.

"It is the Social Security Board's policy," Hendrick stated, "to give assistance to the applicant in furnishing such proof. But the Board's representatives are naturally must have proper evidence that the woman is entitled to these benefits as the wife or widow of the worker in question. The first question is, of course, 'Have you your marriage certificate?'"
