

Ordinance No. C-22-41

To regulate the use and operation of vehicles on the public highways within the City of Farmington, Oakland County, Michigan...

DEFINITIONS

SECTION 1. The following words when used herein shall be deemed to have or include the meaning given below:
Vehicle
Every description of carriage or other contrivance used or capable of being used as a means of transportation...

any notice to appear in answer to a traffic charge under the ordinances of this City except violations requiring appearance in Court may be paid to the City Clerk in person, by proxy, or mail...

against the stop signal if the operator fails to complete stop before entering the intersection.
No Turn at Intersection
Section 15. No operator shall turn a vehicle around at any highway intersection.

the carrying of passengers or merchandise or as otherwise permitted, by this ordinance; provided, however, that this section does not apply to any vehicle whose employment makes it necessary to ride otherwise.
Operator's View to Be Unobstructed
Section 27. (a) Operators shall have an unobstructed view of the rear of their vehicles by direct view or by mirror, windshields in front of a driver shall be kept reasonable clear of snow, dirt or objects so that the driver's view is unobstructed.

No person shall use a loud speaker from any motor vehicle while passing through the streets of the city or parked thereon, without special permission from the city.
Required Lights When To Be Lighted
Section 36. (a) All lights required by this section must be lighted while a vehicle is in motion during the night time, and at such other times when there is insufficient light to render clearly visible to any person on the highway at a distance of two hundred feet ahead.

Size of Vehicle and Load
Section 47. (a) No vehicle shall exceed a total outside width, including load thereon, of ninety-six (96) feet, over all.
(b) No vehicle laden or unladen shall exceed a height of fourteen (14) feet.

RESOLVED by the Commission of the City of Farmington as follows:
SECTION 1. That Grand River Avenue and Farmington Road within the City limits of Farmington, and Warner Avenue and Oakland Avenue from Grand River to Hill Road, and the same hereby are designated as "Stop Streets."
