

hant to sink an American steamer flying the American flag. It did not keep the Germans from declaring half the North Atlantic Ocean a "war zone" and thereby demanding that we keep our ships in port, or close to our own coast. So, step by step, we of the Legion see the history of the last war repeated. American ships sunk and threats of sinking more; rules for the conduct of the Atlantic Ocean being issued by Germany as if she owned the Ocean; and our merchant ships turned loose to attempt to enforce the German rules by promiscuous murder on the high seas.
There is no sense in trying to fool ourselves. It is useless to indulge in wishful thinking, hoping that we can keep out of it all by merely closing our eyes to what is going on. The plain fact is that the American Legion feels that we of America are forced to a positive choice: we can choose to maintain our rights and keep our ships off our American flag flying on the seven seas, or we can surrender our rights to the aggressor, turn the ocean over to the European pirates, give up our trade and commerce with our tax carried between our legs, ready to live off our own fat so long as the big boys stay away and leave us alone.
At the National Convention in Milwaukee, we made our Choice. We solemnly resolved that—Our present National Objective is the defeat of Hitler and all he stands for.

AMENDMENT TO ORDINANCE NO. C-6
AN ORDINANCE TO AMEND ORDINANCE NO. C-6 PROHIBITING THE USE OF FIREARMS
IT IS HEREBY ORDAINED by the People of the City of Farmington that Ordinance No. C-6 be amended by adding the following sections:
Section 5. It shall be unlawful for any person under the age of eighteen (18) years to use any compression or air gun, air rifle or air pistol, slung shot or any instrument throwing or expelling a metal pellet or stone, within the City limits.
Section 7. Any of the above articles used in violation of this ordinance shall be seized and turned over to the Chief of Police to be disposed of by him as the City Commission may direct. Approved Nov. 12, 1941.



Dr. Rodeck was born in Vienna, Austria, and for five and a half years served in the first World War, in Russia, Italy and France. He was graduated from the University of Vienna with a Doctor of Law degree. Instead of practicing law, Dr. Rodeck turned to journalism, and he has been editor, columnist, analyst and correspondent of foreign newspapers for almost twenty years. He was awarded two American prizes in international contests, both for essays in the line of political economy.

Following the annexation of Austria by Hitler, Dr. Rodeck was compelled to leave his native country. He went first to England,

where he remained for six months and then came to the United States in May of 1938. Unable to make a living by writing, he turned his hobby of fencing into a profession, with excellent technical results. Dr. Rodeck is at present teaching at the Dusenberry School in Pontiac.


