TWENTY FIVE YEARS AGO (April 1, 1921)

Clarenceville To Build New School

By an overwhelming vote of 119 to 4 Clarenceville school electors Monday night approved the transfer of \$40,000 from the school district's general fund to the building and site fund, to be used for construction of the new building.

winding up with Sigler being "fired" by Judge Louis E. Casch and Richard Foster, a young attorney, and former prosecuting attorney, being appointed as his successor. Foster will get the same rate of pay — \$100 — which isn't peanuts.

Why should Sigler want to run for governor?
In the first place, it is human nature for an individual, who is frustrated by opponents, to seek vindication of his position in some manner.

If the state supreme court would decline to oust the Ingham county circuit judge from direction of the grand jury in favor of a private attorney, who had happened to be the starting prosecutor, Sigler might adopt a "watchful waiting" policy to see what happens to the two jury indictments which he had previously groomed, one of them being ready months ago for serving of warrants. If the new prosecutor exhibits a zeal to set the bank and gambling indictments through to a finish (assuming that she previously gathered evidence stands up under re-examination) then Sigler's case would be weakened in the eyes of the public which is interested chiefly in results, not personalities.

But therein lies one of the main complications.

The deadline for filing of primary petitions is Tuesday, April 23 — just about a month away. "watchful waiting" policy would automatically exclude Sigler from running for office, since there isn't time to head in one month for the new prosecutor to accomplish the ends which Sigler desires — the indictment and conviction of a score or more persons in Michigan who are next on the list in the bank and gambling cases.

Entry of Detroit Mayor Edward J. Jeffries in the Republican gubernatorial race, as formally announced by Jeffries last week, was predicted in this column last December 27. Jeffries' candidacy was first launched March 6 in the form of a trial balloon, but his formal announcement was released March 12.

Jeffries' candidacy introduces several interesting elements in the primary campaign. He is the spokesman for the big cities and other governments which seek a cut in the state sales tax, as a solution of their tax troubles. Interestingly enough, the election of Jeffries as governor of Michigan would put a C. P. O.-sponsored member of the Detroit council in
