Wayne County voters won't face a jail millage proposal May 16 after all, but they will get a county home rule proposal in the Aug. 8

BOARD CHAIRMAN Robert Fitzpatrick said the consensus was that the jail millage would have a better chance on the November

Thinking would have a better chance on the November ballot. Job oard set the August date for an election on whether voters want to establish a charter com-mission to draft a home rule county charter for later submission to the voters. If voters approve, the charter commission would be elected in November. While state law restricts the latitude of a county charter, it's possible to set up an elected ounty executive or an ap-pointed county manager. A similar 1656 proposal went down, 352,000 to 316,000.
