Proficiency Requirements Reduced for Honorable Discharge A reduction in the proficiency in rating requirements for an honorable discharge has been announced by the Navy, Coast Guard and Marine Corps.

The Navy has reduced its proficiency in rating requirements from 3.0 to 2.75, retroactive to December 7, 1941.

Eligible Navy and Marine Corps veterans should submit a written request for an honorable discharge certificate to the Board of Review, Discharges and Dismissals, Navy Department, Washington 25, D. C.
