ON DETROIT MARKET!

Michigan's politry production is only "scratchink the surface" in meeting the demands of the great betroit market, according to figure and poutry products in the bertoit market in Probratary, Michigan produced only 40 percent of the eggs, 10 percent of the live poultry and 5 percent of the dressed poultry sold on the Detroit market in that month.

C. G. Card, head of the poultry department at Michigan State college, believes Michigan poultry and egg producers are surrounded by the findst markets in the world. Michigan alone consumed the more department at Great and the second of the more department of the more department of the more department of the first market in the world. Michigan alone consumers

are at present produced in the state.

Michigan producers originated \$3,168 of the \$8,424 cases of eggs sold during February on the Detection market. Ohio with 31,903 was second, with Indiana, Illinois, form and Minnesota following.

The story was far different in live poultry. Michigan producers, with 183,000 pounds of live birds, ranked fourth behind indiana's 458,000 Kentucky's 275,000, and Illinois' 220,000. Furnishing approximately 5 per cant of the dressed poultry going on the Detroit market, Michigan ranked ninth in the list. Arkanas, Delaware, Illinois, Iowa Maryland, Missouri, Nabraska and Ohlo all provided more dresses poultry for the Detroit market than did Michigan.


