NOTE TO SAVINGS DEPOSITORS. In accordance with Articles Two (2), eight (8) and nine (9) of Rules and Regulations governing the operation of the First National Bank, Farmington, Michigan, as a member of the Federal Reserve System, and of the Federal Reserve Bank of Chicago, the following method of interest being paid on savings deposits is hereby adopted:

Interest will be computed on the first and December 31st on the balance which has remained on deposit during the six-month period which preceded the respective date mentioned above. Excepting that no interest will be figured on accounts which have been closed or cashed out within the six-month period. Deposits on or before the 15th day of the month will be credited with interest if left undisturbed until the next date. When an account is closed or cashed out, interest will be figured for the time which has elapsed since the last interest date. Interest will be credited to the bank on the first day of June and December, and because of the fact that this date is computed until the end of the month, interest will be credited ten days time following the expiration period before entering the interest date for the next period, the same being made for the purpose of cred-
