(Continued from Page Two) The state has acquired nearly 350 fishing sites, 261 on lakes and 115 on streams. Some land was obtained due to tax reversion; others were purchased from private owners.

Noxious fish, such as carp, have been removed by netting them in 15 lakes. The waters then were stocked with trout.
