REPORT BEST PHEASANT SEASON IN MANY YEARS

With more pheasant hunters out, a considerable increase in the number of birds spotted and a larger kill than in the opening days of last season, preliminary reports from conservation department field men indicate that the 1949 season should be the best in the last three years.

Although not a par with the highly successful seasons of the early 1940's, department field men point out that the 1949 season should be close to average.

In the first two days of the season department observers contacted 1,386 hunters on farm lands who had bagged 1,052 pheasants, nearly a bird apiece. During that first three days of the 1948 season, field checkers contacted 681 hunters on private land who had shot 277 birds, of a little over one cock for every three hunters.

On the basis of hunter report cards, the department's game division estimated 352,000 hunters killed a total of 533,000 pheasants in the 1948 season.

Heavier gun pressure throughout the southern Michigan pheasant range was attributed to the Saturday opening and to the earlier (October 7) opening of the duck season. Last year pheasant and duck seasons opened together on a Friday.
