THE MICHIGAN MIRROR

collective in governments and industries in taxpayers.
If Republican leaders can hold the line by inducing legislators to favor re-creation of present state aid going to local governments, a solution could be found to the treasury deficit and an answer could be thus provided to the challenge by the governor for a tax on corporation profits. However, this is asking for quite a lot.

Michigan corporations have not been such bad employers despite the proverbial onus of "big business". It is significant that Michigan, recognized nationally as the nation's leading industrial state in 1950, paid more wages and salaries to workers in average annual earnings than any other state in the nation. In no other state are factory payrolls as important to the economy as in Michigan. Michigan workers in 1950 received an average annual earning of \$3,650 for a total of \$3.1 billions.

How does Michigan compare with Ohio? Ohio production workers received \$3,260 average in 1950. Thus Michigan leads Ohio by 11.2 per cent and exceeded the national average by 24.7 per cent. As compared with factory earnings of workers in North Carolina, Michigan was 70 per cent higher.

The Detroit Board of Commerce recently pointed out that manufacturing was Michigan's greatest resource and that through it, 41 per cent of the people obtained their livelihood. It was the conclusion of the Citizen Tax Study Committee that a state levy on corporation profits would merely shift additional cost to the consumer in the form ultimately of higher prices. We quote: "In small business as well as big business, it is necessary to adjust pricing to tax cost as well as labor cost and material. In the long run all taxes are borne by the ultimate consumer as part of the cost of goods and services he buys."

Business leaders conclude that a state levy on corporation profits might be the act of killing the goose to get the golden egg. Michigan's distinction of record high wages adds emphasis to this sound logic.

A possible solution to the financing of tuberculosis sanatoriums from state aid has come up in the Legislature. Rep. Robert E. Faulkner,

Iowans Get Their Deer The Hard Way

Deer kill report cards also are compiled in Iowa, but with a little different twist in meaning to the Michigan hunter, for no hunting is permitted in the Hawkeye state until Michigan hunting season reports were due February 15.

According to an Iowa official release received by the conservation department, last year a total of 122 deer were killed in 66 counties . . . mainly by cars and trucks, a few by illegal hunters. Over 350 were victims in 1950.

Permanent closed season prevails on Iowa deer. Recent size estimate of the growing herd is as high as 15,000 head. According to the release, "Conservation officials believe that the deer herd in the state is increasing more than one-third annually and that legal control measures must be adopted in the near future."

Coloma Republican, introduced a bill asking a \$750,000 grant to finance a \$1,500,000 75-bed tuberculosis hospital in Benton Harbor, on a 50-50 basis, whereby Berrien county would match state funds. If local governments elsewhere offered to match state funds, reconsideration of the entire construction program might be ordered.

A slim peach crop in 1952 has been predicted for Michigan. A drop of 25 per cent below the 10-year normal was attributed to the winter kill of a year ago.

Control of collegiate television by law in Michigan, proposing to require MSC and U. of M. to televise sports programs, has been given little support in the present session of the legislature. The legislators defeated a bill to require the colleges to make games available throughout the state, while Attorney General Frank B. Millard has ruled favorable to the colleges running their own affairs as constitutional bodies.

Mennen Williams and AmVet National Commander John L. Smith were among the 400 AmVets present. Post 76 is among the highest, going over the membership quota. The Regional Cup for highest percentage of new members for the month of January was awarded to the Post.
