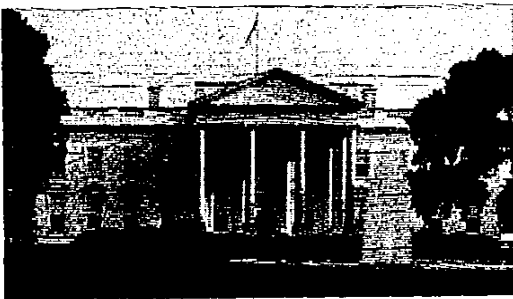


**Secretary-Realtor**

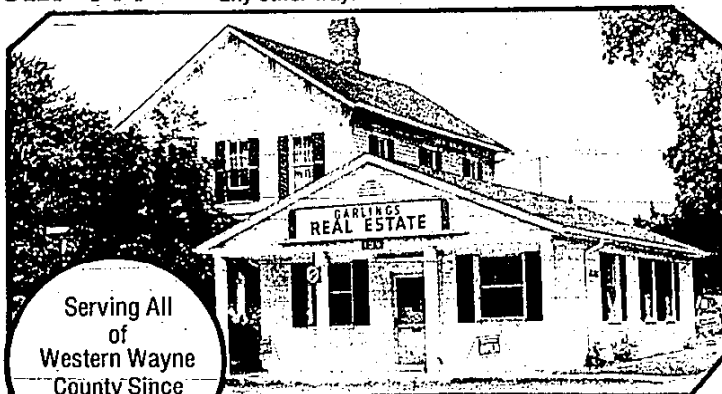
