They'll Assist In Human Drama

Four days a week, Theresa Redden and Vicki Berryhill work as secretaries in the Bureau of State Lottery. On Thursdays, however, they have an assignment which makes other secretaries envious. Donning bright green outfits, they travel around the state to assist in the Lottery's Weekly Drawing and Super Drawing.

Joining Lottery Ladies Vicki and Theresa in the Thursday festivities is John D. Quinn, deputy commissioner for operations of the Bureau. Quinn is the emcee for the weekly Lottery "road show" in addition to his normal duties with the Bureau.

Quinn, 44, was one of the first employees of the Bureau, having been involved in the preliminary work leading up to the creation of the Bureau while serving as a deputy director of the management sciences group in the executive office. A native of Corona, N.Y., he joined state government in Michigan after 24 years in the U.S. Army.

He entered the Army in 1946 as an enlisted man, was an infantry officer for 11 years and spent 12 years as an adjutant general corps officer. The highest rank he held prior to retiring in March of 1970 was colonel.

His last six years in the service were spent as part of a large data processing section, and it is that aspect of the Lottery which he now oversees. Quinn is married and the father of four children, ranging in age from 12 to 21. The family resides in Dimondale.

Theresa Redden, 25, lives in Lansing and joined the Lottery in September after working six months for the Michigan Department of Corrections, and five and one-half years for a Lansing bank.

She was born in Tyler, Tex., but moved to Lansing when she was six. She attended Lansing Sexton High School, went to Lansing Community College for one year and completed a modeling course before beginning her secretarial career.

Vicki Berryhill, 22, is from Grand Ledge, and joined the Lottery in October of 1972. She was previously a secretary in the Lansing offices of the Secretary of State and worked nearly one year for a Lansing insurance agency. Miss Berryhill is a secretary for Quinn.

Quinn, Miss Redden and Miss Berryhill are the on-stage crew at each weekly drawing and Super Drawing.

Court's History Matches City Growth

In 1950 when a 36-square mile area became the City of Livonia, with a population of 17,534, Leo O. Nye was justice of the peace.

Robert H. Lorion was elected Municipal Judge when it became a requirement for the judge to be an attorney and took office in July 1958 and remained in office until July 1966, when James R. McCann was elected.

At the time when Judge McCann took Office, Marie E. Talbot was the court clerk and there was a total of six additional employees. Judge McCann appointed Kenneth Kirkwood as director of probation and under his direction and with the as-

sistance of the Deputy Director Jack Kirksey, one of the first probation departments using almost entirely volunteer probationers was established.

In 1968 district courts were established by the state and on Jan. 1, 1969 the Livonia Municipal Court became the 16th District Court. Due to the population increase a second judge was necessary and on Jan. 1, 1969, James E. Mies took office.

Both judges are full time and have a staff of two secretaries, director of probation, two probation officers, court administrator, two court officers and seven clerk typists and three part-time co-op students.
