World War II and the great surge in automobile buying after the war all played prominent roles in our present road laws, he states.

Of these three roads, only the first can now be changed. According to Graves, some 282 road laws are in direct conflict with each other.

Graves' remedy: A completely new codification of laws. The alternative—continued confusion.

Local industry is not intractable. This is the most important thing people should remember when thinking of community progress, says Don Weeks, director of the Michigan Economic Development Department.

Weeks says that in some cases plants close or move regardless of the local conditions. But, he adds, other Michigan areas have lost their industries when good community relations could have prevented it. Merchant and civic groups, particularly in one-poll towns, are very wise to work with local industries, making the management feel welcome and wanted; encouraging industry progress when it comes to take active part in community affairs.

He lists several eastern states as specific examples, and expresses the hope that Michigan residents will weigh the value of an industry to their communities when voting on issues which affect it.

Khoklov went on to describe the miserable living conditions of the Russians, particularly the workers' families. But Communist officials, he said, lived very well. "I would like to stress again," he said, "that the conflict between the Soviet people and the Soviet Government is not primarily based upon the standard of living. The conflict was and is based upon the lack of personal freedom."

Poverty and slavery thus are the realities of the golden promise of Russia's "workers' paradise."
