

It was generally agreed that the proposed handbook was too formal. Tyrone Leland Clifford stated that he did not feel many parts were in language important enough to inspire reading.

Board President Bayard Turner and Trustee Douglas Hamill were in agreement that the introduction was not necessary and should not be included. In this it contained a statement directed by the North Central Association (school accrediting organization) regarding school board administration-teacher relationships and other matters pertaining thereto.

It was their conclusion that local policy should not be directed by North Central Association.
