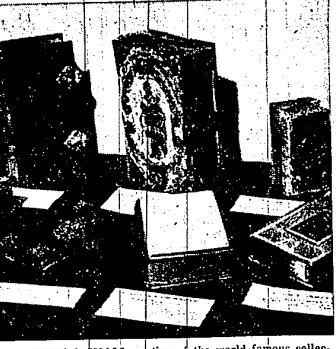

World Famous Bible Collection To Be Displayed in Birmingham

Farmington area residents are invited to view the world famous collection of ancient bibles, scrolls, and manuscripts to be shown for the first time in Birmingham at the Birmingham Auditorium, West Maple at Bates, on April 7, 8 and 9 from 11:00 a.m. to 9:30 p.m. Admission is free.
Sponsors are the United Church Women of Birmingham and their contributions received at the exhibit and through the mail will be used to provide a teacher for the migrant workers in Michigan.
The collection of ancient manuscripts includes a complete King James Bible of the 1611 printing, historic scrolls of early bible writings dating back several centuries before Christ, a page from the famous papyrus scroll, an early Ethiopian bible dating back to 1520, and giant illuminated editions that themselves are rare works of art.
HONALDSON, who has spent over 35 years collecting these historic documents, has been widely written up in the press. Most recently in a feature article in the "Christian Herald."
