

LEGAL NOTICE

Township Board Proceedings

A Regular Meeting of the Township Board was called to order on May 26, A.M., 1959, at 8:07 p.m. by Chairman, Mr. H. C. Cairns. Hers present were Hall, Cairns, Avery, Wilcox, Bassette, Brown and Hug. Township Attorney, also present.

Minutes of meeting held on May 12th, 1959, read by Clerk, Stand approved as read.

Mr. Cairns presented a Resolution for Special Assessment District for sewers in Franklin Knolls Subdivision, the cost of which was \$1,188. Public Acts of 1954, which were left out on original Petition.

At a Regular meeting of the Township Board, the Townships of Farmington and Oakwood, the Township Hall on the 26th day of May, 1959, at 8:07 o'clock P.M., Eastern Standard Time.

PRESENT: Hall, Cairns, Avery, Wilcox, Bassette, Brown, Hug, Wilcox.

ABSENT: None.
