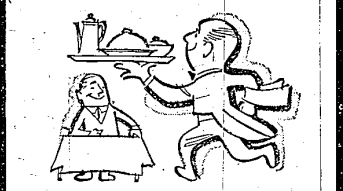


3-Car Accident Injures Girl
