Timely Tips on GARDENING

The golden gleam of forsythia is brightening Farmington gardens, heralding the arrival of the Spring planting season. Star magnolias in full bloom and the clematis magnolias are beginning to open. Many dooryards are enlivened by glowing red Emperor's Choice and garden pink, and blue hyacinths, and dainty blue bellas.

COLONIAL GARDEN - Many of the new homes in Farmington have a colonial motif and are furnished with early American antiques and reproductions. To complement and enhance this decor, yard and garden surrounding the home could also have an early American theme.

Mount Vernon, Williamsburg, and other colonial gardens give us a clue to the plants used. Our ancestors cherished many of the same shade trees which we regard highly. Some ancient white oaks, elms, and sugar maples still survive as relics of the original plantings. Other trees that were widely used in the past are the tulip, hickory, hackberry, horsechestnut, locust, ash, laburnum, shade and dogwood. The bark of the latter, incidentally, was used for medicine and tooth-brushes.

Shrubs that graced colonial gardens included the common lilac, mock-orange, Rose of Sharon, smoke tree, white fringe
