

### Buses to Run In N.E. Area

It was announced this week that the Great Lakes Transit Corp. will begin providing bus transportation service to and from Northland Center, Birmingham and to connection points in Detroit for residents living in the northeast section of Farmington Township.

The service is scheduled to start on a trial basis this coming Monday, Nov. 23, and will be continued for a trial period until it can be determined whether there is a real demand for the service.

In Farmington the bus will run on Middlebelt Road as far south as 12 Mile.

### Delay Action on Dance Permit

Dancing at the Bel-Aire Lanes bowling alley and restaurant - cocktail lounge may soon be able to be enjoyed by City officials want to be absolutely sure that no problems will result before approving of such a permit for this establishment.

The establishment has requested a dance permit from the State Liquor Control Commission along with its Class C Liquor License. The state commission, following normal procedure, has asked for an opinion from the City Council on this request.

At its meeting Monday night, the Council instructed its city manager and director of public safety to make a thorough investigation and report back.

The owners of the establishment will be asked to submit a floor plan showing where they propose to allow dancing and how much floor space they will have for it. They will also be asked to outline a program specifying when they plan to allow dancing, what kind of music will be provided and other details.

A decision on this request will be made at the next regular Council meeting on Dec. 12.

work together toward the solution of a race problem, and in the process, many misunderstandings based on religious differences are dissolved. A spirit of unity develops which can only strengthen a community.

3. That there is a growing urgency at the grass-roots level to search for some kind of plan that will bring positive-minded people together to work out a solution to our race problem.

4. That courage is contagious. When men of good will realize there are other intelligent, decent people who share their sentiments, they are more willing to stand up and be counted in the cause of true Christian brotherhood.

5. That a few well-informed, convinced individuals can counteract the effects of the hate groups by influencing that great majority of people who are decent and fair-minded, but puzzled and frightened.

6. That the appearance of Negro leaders on these programs has done much to dissipate the common stereotype. Negro leadership is, in turn, encouraged to find worthy people engaged in self-education, in sincere effort to bring their attitudes in line with basic morality and up-to-date facts.

7. That the two Communist charges so often leveled at human relations groups is impossible to make stick, because of the religious orientations of the groups and the affiliations of the members.

8. That no race can excuse itself from taking steps to improve its leadership by saying, "We'll accept them if they're nice," in the face of the facts learned in three widely separated parts of the metropolitan complex.

In each case Negro families of socio-economic backgrounds similar to or superior to that of the majority of the local residents, moved in, only to be subjected to burning of their homes, threats to their lives, extreme emotional and physical harassment, and total social ostracism, all of which has been done by so-called "nice" people.

It took this recurring kind of incidents, coupled with the knowledge of the rising aspirations and increased economic status of the Negro population, to convince the city bishop's Committee that some continuing type of educational program was needed to develop understanding of informed citizenship by men of good will in every part of the community. Otherwise, lawlessness and hatred will flourish.

### City Questions School's Terms

Terms and conditions which the Farmington Board of Education is insisting on if the proposed "model square" is to be located at the northwest corner of the Planners School site were not too well received by members of the City Council at their meeting Monday night.

At least two or three members of the Council were of the opinion that if they were required to stand most of the cost for the walk and blockade the School Board is insisting on in addition to the cost of constructing the "square," it would make the project too expensive to go ahead with.

The city manager was instructed to continue negotiations with school officials and a representative of the home-owners association for the development around the school to see if a more equitable solution might not be able to be worked out.

Hopes of getting the "square" constructed here next Spring have now been abandoned.

On the second and third days motorists exceeding the posted speed limit by more than ten miles per hour will be issued warning tickets.

THE FOURTH day will be set aside for just recording speeds. Motorists traveling again in an effort to determine what results have been obtained in getting speeds reduced as the result of issuing warning tickets. If violations of speeding have not been reduced by 50 per cent or more as determined by the timing done on the fourth day then on the fifth and following days actual violation tickets will be issued motorists going over 10 miles faster than the posted speed limit.

Councilmen were assured that all major roads leading into the City had now been posted to advise motorists that speeds in excess of the community were electrically timed.

City Manager John Dinan told councilmen that every step possible would be taken to improve upon motorists the fact that this was a safety study program being conducted by the City and not one of setting up speed traps to gain revenue for the City.

### Deer Hunters Having Good Yr

The Michigan deer hunting season which opened last Friday, November 15, in the lower peninsula with temperatures still hitting the 40s and 50s, brought many hunters back early with their game.

The first Farmington man to return with his deer was Homer Howard of 1801 West June Mile Road. More than 250 deer have been received at Conroy's Market for storage and processing since Howard brought in his.

A RECORD 108 deer were dropped off at Conroy's on Monday, far outstripping any other single day in the history of the local deer processing plant.

It is not known yet whether the all-time season record of about 400 set several years ago will be reached by Farmington hunters with still several days left in the 1954 hunting season.
