NEW SERVICES

Want to call more places in the Detroit metropolitan area more often-and talk as long as you like-without worrying about extra charges?

If so, you'll want to know about two new optional services designed to make telephoning more economical for GReenleaf (and 47) customers:

Metro-21

Metro-21 is a residence service that enables you to call as often as you wish and talk as long as you wish to telephones in Detroit and 79 surrounding communities for a flat monthly charge. The individual-line service is in effect for 21 hours daily—from noon to 9 a.m.—and all day Sunday and on Christmas, New Year's and Thanksgiving. Metro-21 adds six afternoon hours to Metro-Calling Service, which is especially helpful to those who want to call during normal business hours.

Metro-Calling Service, already available, offers the ame features as Metro-21 but for 15 hours (6 p.m. to 9 a.m.) instead of 21 and at a lower price. This service is particularly useful for evening and Sunday calls to make social engagements and keep in touch with friends and relatives.

The calling area for both Metro-21 and Metro-Calling Service is shown at right, and also on Page 10 of your local telephone directory.

Super Extended Area Service

Super Extended Area Service, avaj able initially on a trial basis to both residence and business customers, adds more of Detroit to your present local calling area. For a single monthly rate it gives you unlimited individual-line toll-free phoning to Downtown Detroit, the Midtown-New Center area, more of the northwest side of the Detroit Zone, and all of the GLenview (Plymouth) Exchange. Business custo will pay only 4.2 cents (one message unit) for each call to the Detroit portion of the Super Extended Area, regardless of the duration of the call.
