remain as before, but the polls will be moved to the Illich-meadow School for its 1,118 voters.

Nothing is changed for the 1602 voters in precinct four as the boundaries remain the same and the polls will continue to be at the Bond School.

Precinct five is bounded on the west by Middlebelt and on the east by Inkster. The southern boundary is Grand River while its northern boundary is Shawassee. Its 778 registered voters will cast their ballots at the William Grace School.

In precinct six the 808 registered voters will continue to vote at the Shawassee School. However, the boundaries have been changed to include the Township area in the parcel 10 Mile Rds. and Orchard Lake and Middlebelt Rds.

Boundaries for precinct seven are: 10 Mile, Grand River, 12 Mile and 12 Mile on the north. Powers Rd. and Orchard Lake Rd. form the eastern boundaries, while

Manager Dinan to contact all the property owners on Grand River to determine if they would be interested in purchasing the property south of the stream which the city owns.

Charles Hannan and Virgil Cornwell have both expressed an interest in this property, but the Planning Commission had voted to recommend that the City retain the land. The Council felt that all the property owners should be canvassed and then it would make its decision.

The members told Dinan to report back at its next regular session with the information.

In other action the Council:

- Introduced an amendment to the swimming pool ordinance which would require either a cover being placed over backyard portable pools or a safety lock attached to any gates into the yard;
- Heard a letter from the Farmington Youth Guidance Committee outlining their needs for the coming year and requesting a total city allocation of \$300 as opposed to last year's \$200 budget;
- Directed City Manager Dinan to set up a meeting with Gordon Howe and Associates to discuss the feasibility of that firm erecting an indoor ice skating rink in the city; and,
- Told Dinan to examine and report back on a request from LaSalle Wines to backfill a portion of the backend of their property.

answer the repeated objection voiced at every public meeting held to date, that if the township incorporates the taxes will inevitably rise. The report said, "Specifically we find that the cash needs of Farmington Township are, and will be, based upon the level of services we residents want and are willing to pay for. We have not found any duties a city must assume which are not also borne by a township and which must be paid for out of tax income."

The committee reported figures which showed that, as a city, Farmington could have received the same service currently provided by the township, with no tax increases, and ended the year with a surplus of \$12,500.

Thomas Duke, a member of the incorporation committee, told The Observer that there was no puffery in these figures. "What some of these people don't seem to realize," he said, "is that the township is speaking of the proponents of the 'why-are-there-any-negative-findings' attitude, that we on the committee are

Issue Is Big

The purpose of the Incorporation Study Commission public meetings is, according to Chairman Terry Brennan and every one of his committee members, to provide a basis of information and understanding on which township residents can base an educated vote.

An election on the incorporation issue has been recommended for Monday, June 6, by the Boundaries Committee of the Oakland County Board of Supervisors.

Yet the attendance at these public discussions, the figure for the most recent meeting set at about 60 persons, indicates that residents either don't seem to care or don't anticipate the election being held.

The first public meeting was held Jan. 17. Almost two hundred persons attended. During the course of the three meetings held since, attendance has rapidly declined from 120 to 90 to 60.

The issue is important.

Farmington Man Wins Case in Court

A Farmington resident, Donald F. Welday, Jr., of 2290 Manning, has won a case in the United States Supreme Court which has been termed "of major importance in the field of labor-management relations."

The decision of the Court in the case of Lina vs. United Plant Guard Workers of America, established the principle that malicious and defamatory statements made during union organizational campaigns are now subject to court suits for libel and slander.

Earlier Court decisions had held that personal damage suits were barred in labor matters except where actual physical violence was involved.

Supreme Court Justice Clark noted in the Court's opinion that "malicious libel enjoys no Constitutional protection in any context. After all the labor movement has grown up and must assume ordinary responsibilities. The malicious statements in any form cannot be condoned, and unions should adopt procedures calculated to prevent such abuses."

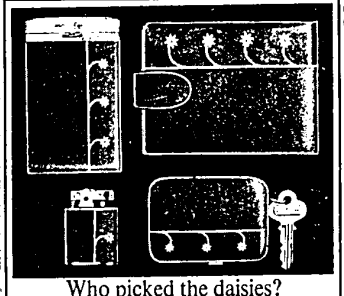
