

PCHA Approves Pact With Attorney General

The Attorney General's civil suit against the Peoples Community Hospital Authority has been dropped in Ingham County Circuit Court by Judge Marvin Salmon.

Judge Salmon agreed to drop the suit after the PCHA board of directors voted to enter a consent agreement with the court which gave the attorney general lasting supervisory powers.

Attorney General Frank J. Kelley had drawn up the agreement and said the state would withdraw its civil case against PCHA if its board of directors approved the consent agreement.

Named as defendants in the civil suit were: Edward McNamara, former PCHA board chairman; Gordon Gable, former vice-chairman, and Kenneth Gremore, former executive director.

Gremore was dismissed as executive director for misuse of PCHA funds and failure to follow board directives. McNamara and Gable declined to run for re-election after being named

The purpose of the civil suit against PCHA was to prevent an alleged transfer of the Authority's assets to a private corporation, a move which Senator Roger Craig (D-Deerborn) has said would be done with a \$18 million bond floated by the R. F. Snyder Co., a Wisconsin investment firm.

The consent agreement now entered into prohibits any transfer of PCHA assets unless approved by the court after notice to the attorney general. Such a provision will prevent any outright transfer of the PCHA to a private concern.

Other provisions of the agreement will:

- Prohibit board members, officers, agents or employees of PCHA from using any of the Authority's funds for private or personal use.
- Require PCHA to maintain a system of competitive purchasing.
- Prohibit the board of directors from delegating any of its authority.
- Prohibit board members, officers or employees of PCHA from transacting business with the Authority.

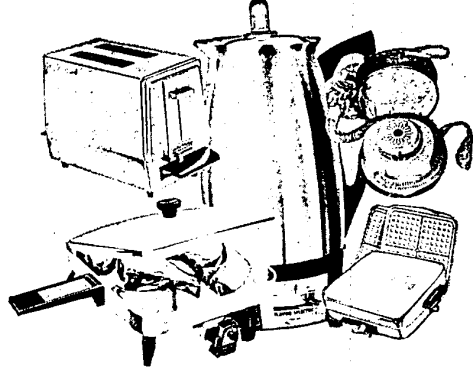

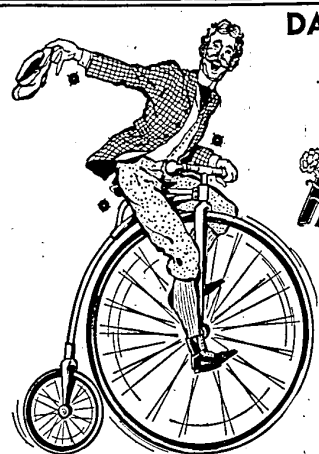

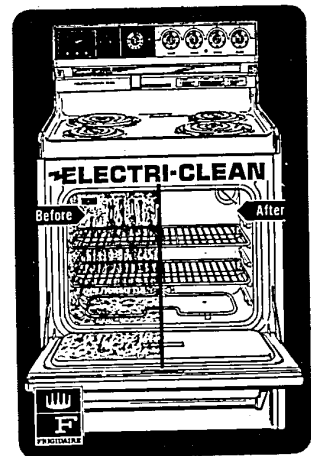
