Continuum Class Opens New Session

A new counseling and testing session for women, a Continuum center program at Oakland University, is scheduled to begin Jan. 5.

Almost 550 women in earlier sessions have taken advantage of the opportunity to learn more about themselves in this "Investigation Into Identity" course which has been designed expressly for the woman who is exploring the possibilities of education, volunteer service or employment in the complex world outside her home.

The first session is an interview, one free to anyone interested in learning more about the program. At this initial meeting, Director Priscilla Jackson describes the Continuum center and what it offers.

The group then breaks into subgroups of six for discussion, led in each case by a woman who has already gone through the counseling and testing program. The tests, specifically adapted to measure the aptitudes, interests and abilities of each woman, are

devoted to a discussion of the factors which may influence a decision. This is followed by a one-hour personal interview with Dr. Self in which he interprets and explains the test results.

In addition to this course, women are welcome to consult at any time with the staff advisers who include a trained social worker, an expert in the personnel field and an ed-
