The bipartisan loyalty board was scrapped, McCarthy's charges became the chief issue of the campaign, and some of the President's staunchest supporters were defeated.

Bounty payments on foxes, cop-toes, bobcats and wolves dropped to \$13,529 in November, the conser-vation department reports. Tally of November payments shows 1,730 foxes, 312 coyoles, 74 lobcats, and six wolves turned in for hounty.
