McConnell Tops Teeples; Cairns, Nolan Victors

As of 11 p.m. Tuesday, incumbent Township Supervisor Earl Teeples had apparently been ousted by challenger Robert McConnell in the Republican

mrimary.

McConnell was ahead, 2,163 to 1,962 for Teeples, with all 22 precincts reporting.

The race for supervisor went down to the wire with north end precincts 3 and 16 being late to report.

Precinct 16 at Fairview Elementary School was

late due to a power failure caused by lightning in Tuesday's day-long rain. Election workers counted votes by candlelight. Incumbent Treasurer Thomas Nolan and Clerk

Floyd Cairns easily won renomination in the GOP

primary.

Teeples was defeated after a single two-year term. As a police sergeant under fire from the township administration, he upset veteran Supervisor Curits Hall in the 1970 primary.

McConnell rose to prominence as leader of the Entire Ferminaton Assn. a group supporting city-
