

SEN. ROBERT GRIFFIN

THE SENATE AND EDUCATION POSTS

A long list of state candidates faces each voter in the Nov. 7 election beginning with the races for the U.S. Senate seat.

U.S. SENATE

Top runners in that race are Republican incumbent Sen. Robert Griffin and Democratic Att. Gen. Frank Kelley.

Frank Kelley.
Griffin, 48, is assistant minority leader in the U.S. Senate and has served as a U.S. congressman and state representative. Kelley, 47, was practicing attorney until he was appointed attorney general in 1961. He has been reelected four times.

Other candidates include Patrick V. Dillinger, American Independent Party; James Sim, Socialist Labor Party; Barbara Halpert, Human Rights Party; Linda Nordquist, Socialist Workers Party; Thomas D. Dennis Jr., Communist Party.

STATE BD. OF EDUCATION

Two persons will be elected to the State Board of Education. Running on the Democratic ticket are incumbent Charles E. Morton, 46, who is a minister and teacher; and Gumecindo Salas, 30, a professor in Monteith College at Wayne State University.

On the Republican ticket are William A. Sederburg, 25, a doctoral candidate at Michigan State University; and Edmund Vandette, 40, an associate professor of social sciences at Michigan Technological University. Vandette was selected outstanding educator of America.

Other candidates include Mary G. Calder and Frederick S. Kline; American Independent; Thomas E. Girard and Edgar Thomas, Socialist Labor: Howard L. Jones, Human Rights; and James E. Wells, Conservative.

U. ONM. REGENTS

Six persons are running for the two seats on the University of Michigan Board of Regents.

On the Republican ticket are Deane Baker, 47, who is president of the construction firm Deane Baker Co.: and Lawrence B. Lindemer, 51, a lawyer who has been on the board since 1968.

Democratic candidates include Marjorie Lansing, of Ann Arbor and Thomas A. Roach, 43, attorney and partner in the firm McClintock, Fulton, Donovan and Waterman in Detroit.

Other candidates include Vito J.
DeLisi and Joseph Toth, Socialist
Labor.

MSU TRUSTEES

The two Democrats running for the two seats on the Michigan State University Board of Trustees include Tom Downs, 56, an attorney from East Lansing; and Donna O'Donnohue, 23, who is publisher of a Berrien County monthly newspaper and a researcher for a law office.

On the Republican ticket are Aubrey Radcliffe, 33, a Lansing teacher; and Jack M. Stack, MD.34, a general practitioner in Alma.

Also running for the seats are James Horvath and Frank Troha, Socialist Labor; and David W. Brinn, Human Rights.

WAYNE GOVERNORS

Two persons will also be elected to Wayne State University's Board of Governors.

Wilber M. Brucker Jr. and Kurt R. Keydel are both incumbents on the board seeking reelection on the GOP ticket. Brucker, 46, is currently board chairman and Keydel, 67, is vice chairman.

Democratic challengers are Kathleen Straus, 48, an inter-agency liaison officer for the southeast Michigan Council of Governments; and Michael Einheuser, 20, a student in Monteith college at WSU.

Other candidates include Terry Lindsay and Lowell Miller, Socialist Labor; Peggy Goldman, Communist; and Peter E. McAlpine, Conservative.
