Ownership of Oakland County Homes

The United States Census Department at Washington has just issued a bulletin dealing with the ownership of Oakland county homes. The important facts contained in the bulletin relative to this country are as follows:

There are 12463 homes in Oakland county, of this number 4796 are farm homes. The mortgaged farm homes are 1544. Renters occupy 1131 farm homes in this county. 7667 homes are urban, there are 4066 urban home owners, 1185 are mortgaged, 2948 are free of incumbrance, 3235 are rented.

The census enumerators were unable to secure data pertaining to the ownership of a small percentage of both the rural and urban homes in this county.

In speaking of the special tax levied on automobiles, an officer of the Ford company, made the assertion that 300,000 cars will be manufactured this year. That the company really expects to make that many cars is a certainty, which will be good news to buyers of the cars, who will benefit to the extent of \$40 to \$60 each.

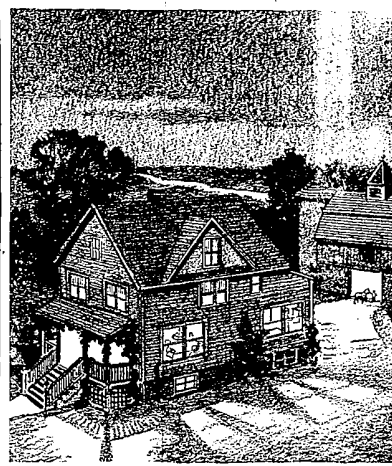
