

AMONG THE FARMERS

"Safety First" among the farmers and their employes as well as in the factories and shops of the big cities is urged in the following editorial, taken from the Pontiac Press-Gazette:

"In the news stories from about Oakland county last week there have been several which dealt with accidents to farmers and their employes, resulting in more or less serious injuries. For instance, one man was very painfully and perhaps seriously hurt when a land roller, which he had weighted with heavy stones, over balanced, toppled backward and caught him under it, the stones crushing his body. At Ortonville a farmer employed in running a gasoline engine to operate farm tools was caught in the wheels when he reached over to tighten a burr, and had a leg broken and the flesh torn from an arm. More than half a dozen farmers in this county have been hurt during the past few weeks by falling from loads of produce either on the road or in leaving the barn. Other instances are numerous.

All this goes to prove right at home the statement which investigators of the need for safety-first movements have found to be true, namely that a large percentage of the accidents occurring in industrial life are in agricultural pursuits.

This seems to point out the need (or precautionary educational measures among the rural population as well as among the employes of factories and big shops. Though the problem is not extremely simple in the city it is still less so in the country, for while the city employer can reduce the risks in his shop to certain stated and definite circumstances, the farmer will find it hard to do so. Few accidents in the country occur under exactly the same set of circumstances, while in the factory the same sort of accidents usually come from the same basic reason.

However, a large share of the unfortunate occurrences which cost life or limb in both city or country are due to carelessness fundamentally and a general campaign for care and caution would do much good in either place."
