BUSINESS NOT DISTURBED.

With the opening of the national campaign it is the expressed opinion of the financial world that the usual depression in business attendant upon a national campaign will not materialize this year, and that business will not be disturbed. The Michigan Investor, in an editorial recently, had the following to say regarding the presidential campaign and its effect upon the business of the country:

"Two great men have been nominated for president by the two great parties. Two thoroughgoing Americans, both men of force, scholarly men; men who are large enough to deal with the problems before the country in the coming campaign; men who will not soil their hands by slinging mud; men who have a right to and will command the respect and loyal support of the members of their respective parties.

"Fortunate it is for the business interests of the country that there will be little or no business disturbances caused by the presidential campaign of 1916. This feeling is being reflected in many ways, through the press and in the utterances of leaders in the business world. The liberal attitude of President Wilson toward big business emanating from his spirit of fairness and good common sense, has eliminated the fear of upheaval usually in evidence during presidential campaigns, while Charles Evans Hughes when governor of the state of New York emphatically served notice on the people that 'Big Business' and corporations, when in the right, cannot be baited for political effect.

"While it is realized that which ever man is elected he will have great problems to solve, the knowledge of the high character of both candidates gives assurance that patriotism will take precedence over politics, and that the welfare of the people will receive careful consideration. The prospects are not pleasant for the professional politician, but are hopeful for ordinary citizens. In the meantime business will go on with but little disturbance due to political agitation."

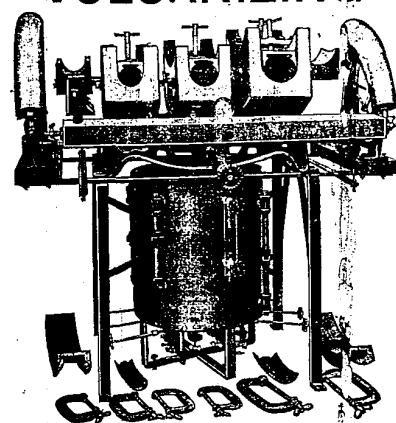
