## Administrators Pay Is Hiked

FARMINGTON A five per cent increase in salaries and hourly rates for employees not covered by bargaining units in the Farmington School District was approved during the recent board meeting.

Salaries for executive secretaries, non-certified supervisors and administrative personnel, and hourly rates for students and non aides increased by five per cent unless a promotion occurred.

Executive secretaries sala-

ries range from more than \$9,400 - \$10,400. Non-certified supervisors earn salaries ranging from \$9,000 to more than \$14,000.

Administrators' salaries range from more than \$23,300 to more than \$35,400 for the superintendent.

The hourly rate for noon aides has been approved at \$3.40 per hour this year while students earn \$1.89 per hour for the first 15 weeks. At that time students receive a raise to \$2.05 per hour based upon a satisfactory performance.

# Susan Jaeger Reward Fund Still Taking Contributions

FARMINGTON A reward fund for information on the kidnapping of Susan Jaeger is now over \$8,000, according to the sponsors of the fund.

The fund was established a month ago to collect money as a reward for information leading to the return of Susan unharmed, or the conviction of the persons responsible for the kidnapping.

Susan, daughter of Mr. and Mrs. William Jaeger, Farmington, was apparently kidnapped from a tent while the family was camping near Bozeman, Montana, last June.

A ransom call was received by the parents a week later, but no further contact was made.

Most have been \$1 or \$5, with letters of encouragement for the family.

## Milk Prices Going Down

Milk prices were scheduled to increase this week by one cent per carton due to increased dairy prices; however, federal reimbursements for milk sold at both the elementary and high school levels prompted a price reduction.

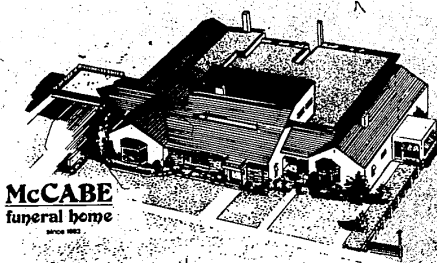
