

'Brother Of Wind' New Breed Of Nature Film

Many things place "Brother of the Wind" several cuts above the usual nature and Walt Disney film.

This small company film starts with the assumption that the wolf isn't simply a demon; that he has a place in nature and deserves normal respect.

Disney gives personality to the animal who is the hero of each film, and the hero's enemies are cast in the role of villains. The death of either the hero's relatives or enemies is soon in emotional terms, as good or bad.

Not so with this loopy, eye-kill, spectacular glimpse of an aging hermit who raises four wolf cubs after their mother is wantonly slain by a bush pilot.

John Monroe gives the cubs milk, but then he tries to teach them to hunt. The first encounter — with an elk and a raccoon — are hilariously unsuccessful.

Toward the end, however, you see the bounding young cubs thrash a muskrat, trap a young buck deer in a pincer movement, and wear down a good-sized elk. The prey is downed before your

eyes. No moral judgment is made by actor or narrator. Wolves kill to eat — it's that simple.

John Monroe kills game, too, and you accept that. What you don't accept is the way the she-wolf is killed from the air and one of the half-grown cubs is pursued by a snowmobile and shot for no reason. (Funny thing: In snowmobile commercials on TV, you hear orchestral music; here, you hear the music — a snowmobile makes a flatulent racket.)

The viewer, was amused by the incredible similarities in actions and voice messages between the wolves and his own house dogs. Indeed, there's a certain black poodle of my acquaintance who could have taught the wolves a thing or two about landing a fish.

The only blemish part is the conclusion. The cubs and the wolves return to save old Monroe from an attack by a black bear. Apparently the director saw it as necessary to prove the moral of the story.

The film is a free spirit — it's not independent wolf — who returns voluntarily to his last quartet.

Is it too bloody for children? The youngsters who saw the film the night I did showed no ill effects. Take the kids, by all means. But it's not a "kids' film" so an adult can see it in comfort.

The genre: Breath-taking — the Canadian Rockies in Alberta. It fills a lot of film time, but "Brother of the Wind" is much more than a travelogue.

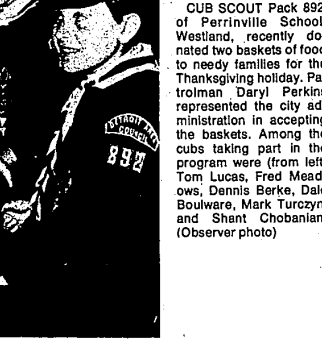
