A substantial campaign contribution was also made by Norman I. Leemon, of Detroit, who contributed \$1,500.

The other successful candidate Mrs. Schaeffer spent \$581.

Mrs. Schaeffer was able to raise \$585 which leaves her \$4 with which to begin her new campaign.

With the exception of one \$250 contribution, all of Mrs. Schaeffers contributions were for \$100 or less.

The most expensive campaign was conducted by Clair Carney who spent over \$3,200 for advertising, mailings, bumper stickers, and other campaign

The vast majority of Carney's donations were under \$50.
His most substantial campaign came from Kenneth Davies of Detroit who contributed \$491.

BRUCE SAPERSTEIN was the most frugal candidate. Saperstein only spent \$230 on his campaign.

Although his expense account shows that all his debts were paid, it does not indicate where the campaign contributions came from.

Gerald Freedman was the only candidate whose committee was left with any debts. In addition to \$1.400 in expenses which the Freedman for Judge Committee paid, there are still over \$1,000 in unpaid debts.

The committee raised most of its funds through \$25 and \$50 contributions from individual residents.

Edward Reagan, who spent over \$1,400 on his campaign raised the majority of his funds through ticket sales to a fund-raising dinner.

Frank Hill spent over \$780 on his campaign, which was financed primarily by \$10 and \$20 contributions.
