



#### Bids Wanted.

Bids will be received for the construction of a reinforced concrete bridge known as the "Pike" bridge. Bridge to be 6 feet long, with 16-foot roadway, 6 feet from bed of creek to bottom of slab. With wings 6 feet north and 3 feet south. Walls to be 2 feet at bottom and 10 inches at top, foundation to be 2 feet below bed of creek. Wings to be tied to walls with three-quarter inch rods, two feet apart. Slab to be 8 inches thick, reinforced with three-quarter inch rods, spaced six inch centers lengthwise and 24 inch crosswise. Walls to be 1 in 5 and 1 slab in 4, with 2-bar rail on top.
