

In a classic case of role reversal, members of Farmington's student round table advise the administration about problems that have been haunting school meetings throughout the year.

Recently, student representatives from each of the high schools sat their hands at coming up with a solution to the problem of smoking in the hallways.

In trying to solve the problem, the youth advisory group came face to face with a difficult situation.

They wanted to designate a specific area or area within the school for smokers but were advised by the administration that such a solution would be impossible.

I can't see any school board member, the last I saw, that would support ever

ever publicly saying how we encourage smoking through the establishment of a smoking lounge," said School Superintendent Lewis Schulte.

"I don't think we'd get anything done but we'll give it a try," said Tim Sundt, a junior at Harrison High School.

"I can help here, or at least try to," explained Jeruzene Gugel, a senior at Farmington High School and chairwoman of the round table.

I wanted to do something for student government, and I never quite made it to student council," she said.
