By now, the Equal Rights Amendment to the U.S. Constitution should have gone away as an issue, at least in Michigan where the legislature ratified it in 1975. Both the U.S. and state attorneys general have ruled that a constitutional amendment, once ratified, can't be rescinded. But scare stories keep ERA controversial anyway.

But scare stories keep LTA Controversian any-way.

Here in suburbia, R. Robert Geake credited his March state senate victory to anti-ERA feeling. And suburban Girl Scott leaders, protesting their national organization's and metropolitan council's endorsement of ERA, say their only quarrel is that they didn't get a chance to vote, although the truth is that it's mainly anti-ERA forces raising the ruckus.

THE PROPOSED 27th amendment to the Constitution states: "Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex." The rest of the text concerns implementation. The key to what it all means lies in the U.S. Senate Judiciary Committee report, which the courts are certain to consult before deciding ERA-related cases.

The area Girl Scott leaders, had they truly understood ERA, should be supporting the stand of their national and metropolitan leaders on ERA and settling their voting rights fuss quietly. And Sen Geake, though he may have found an anti-ERA stand was good for votes, does his district a disservice when he pretends Michigan's ratification of ERA can be changed. Geake should be educating his anti-ERA admirers rather than exploiting them.

And instead of thoughts on how to stop plea bar-gaining in the courts, we got treatises a bout how putting criminals in jail would stunt their rehabili-tation.

In short, time was when politicians appeared more interested in the rights of criminals than in the rights of society or the victims of crime. Today this has all changed.
Oakland County Prosecutor L. Brooks Patterson has been making a lot of waves with his proposals to tighten up on what is plainly a sloppy parole system—it releases a lot of convicted criminals back into society before they are ready for it. Wayne County Prosecutor William Cahalan has been getting much publicity with his proposals for mandatory minimum sentences for anyone convicted of a felonow holds that if you are convicted of a crime committed while you have a gun on you, you'll get an extra flat two years in the slammer in addition to the regular sentence.

There are also a number of negatives. The center was never intended for use as a prison, but rather as a campus for children with learning problems. It looks like a picturesque college campus. It certainly will not be easily converted into a medium-security prison.

Furthermore, more than one-third of the land in Northville Township is already off the tax rolls: Northville State Hospital. Plymouth Center for Human Development. Hawthorn Center for disturbed children. Maybury Urhan State Park. Our Lady of Providence Home for Girls, the women's division of the Detroit House of Correction. Hines Parkway and the Michigan State Police area post district headquarters and crume lab.

needs more prison space—promptly.

The Air Force announced last week it will close
the facility, throwing the community, which is already hard hit by unemployment, into an uproar,
Part of the base could be turned quickly into a
prison, and the jobs associated with it would help

What, then, for the child development center?
Some people want it thrown open for private development. If not that, a useful purpose would be served by turning it over to a consortium of Schoolcraft College and Wayne State University, which could run it as a campus for vocational education.
