Since the Michigan State Constitution was adopted in 1963 there have been 41 attempts to amend it, only 15 of them successful. Any amendment to the constitution has to be approved by voters.

Voters have turned down several atempts to allow a graduated income tax instead of the flat rate tax now allowed and three times rejected proposals to lower the minimum voting age from 21 to 18 (now allowed by the federal Constitution).

Most attempts to limit state spending have been defeated, the notable exception being the Headtee amendment approved in 1978.

# Lucas loses a vote but gets his way

A COUNTY executive in Wayne County has a good thing going, and Bill Lucas knows it.

knows it.

The executive appoints members to the board of the Economic Development Corp. with the approval of the County Commission — just like a president appointing an ambassador.

But there is a quirk in the EDC law, as related out by George Cross the commission.

pointed out by George Cross, the commis-sion's research chief and a former corporation counsel.

"A board member holds over under the law until a successor is named," Cross told the commission recently. "Lucas hasn't named anyone."

THE ODD situation involves Dr. Samuel Ajiri. He has served a term on the board, and Lucas attempted to appoint him to a new term.

The County Commission objected, and here we run into another odd quirk. The commission's 15 members meet as a "committee of the whole" to go over everything. A week later, they finalize their actions by meeting in a commission session.

well, the committee of the whole voted Well, the committee of the whole voted overwhelmingly to reject Ajiri. As Commissioner Kay Beard, D-Inkster, tells it, Lucas withdrew the Ajiri nomination before the commission could act officially to reject Ajiri a second and final time. So now Lucas is keeping Ajiri on the EDC board by the simple process of not naming anyone to replace him. Clever, eh?

AJIRI HAS been Lucas' point man in efforts to get rid of EDC director Robert FitzPatrick, who ran for county executive

In that campaign, Lucas failed to show up for most of their debates. The one time I saw them on the stump together, FitzPatrick made Lucas look — well, piti-

So when FitzPatrick lost the election,

that's politics. So what?

Commissioners didn't like Ajiri's tactic of leveling flimsy charges against FltzPatrick, who enjoys widespread re-

spect.

It also left a bad taste in their mouths that Ajiri's is second in line to take over the former Wayne County General Hospital if Southwest Detroit Hospital can't make a go of it. Rightly or wrongly, they see Ajiri as trying to curry favor with Lucas by working to dump FitzPatrick.

I don't know, of my own knowledge, whether the commissioners are right or wrong about Ajiri. But if it's any clue, they are virtually unanimous.

THE POINT is that Lucas is able to keep Ajiri on the EDC board by the simple tactic of declining to appoint a successor. For their part, the commissioners seem to have made two serious errors:

1) Holding committee of the whole sessions. These lead only to delays and gamesmanship. Items of business should go directly from standing committees to the full board without a redundant hait in a committee of the whole.

2) Approving the appointment of John E. Johnson Jr. to the EDC board as a replacement for Maurice Vermeulen, who resigned. Tactically, the board should have held up the Johnson appointment, leaving the Vermeulen seat vacant, until Lucas names a successor to Ajiri. By confirming Johnson, the commission threw away its trump card.

For a candidate who did so badly in debates, Lucas certainly has shown a mastery of legal loopholes. He gets his way.
