## School board takes no action on Hills school site offers

The Clarenceville School Board last week reviewed two offers to purchase the Westbrook Elementary School property in Farmington Hills.

No action was taken to accept either offer while trustees told their attorneys to draft language so that both parties can-rebid.

Ed Salisz, assistant director of business, said the trustees wanted the language to reflect that the board would make no improvements on the property in-order to sell it. Both prospective buyers reportedly included such provisions in their offers.

"They (the trustees) want to sell it as is," Salisz said. "We don't want to put any money into it regardless of what the problems are."

In past weeks, the board received a \$50,000 offer to sell the land to a small group of investors who want to develop a nursery school-cultural center for American Mostems of Indian and Paki-
