Also that part of T. 1N., R. 9E., beginning at a point on the South line of Section 34 located distant East 2003.18 feet from the S.W. corner of Section 34, which point is coincident with the S.E. corner of the boundary of the City of Farmington, proceeding thence southerly along the easterly boundary of the City of Farmington northerly 284.65 feet to the E. & W. 1/4 line of Section 34; thence westerly coincident with the E. & W. 1/4 line of Section 34 and the boundary of the City of Farmington to a point located 86.12 feet east of the West 1/4 corner of Section 34; thence northerly coincident with the boundary of the City of Farmington 2,655 feet to the North line of Section 34; thence easterly coincident with the northerly line of Section 34 and the boundary of the City of Farmington to a point on the northerly line of Section 34 located 178.5 feet west of the N.E. corner of Section 34; thence southerly 117.75 feet coincident with the boundary of the City of Farmington; thence southerly 568.55 feet coincident with the boundary of the City of Farmington; thence northerly 892.18 feet coincident with the boundary of the City of Farmington to the E. & W. 1/4 line
