Gribbs Campaigns To Stay As Sheriff

Democratic Sheriff Roman S. Gribbs will go against Plymouth Republican James E. McCarthy in his first test at the polls after taking over the scandal-rocked department.

Gribbs rolled up 88,434 votes in the primary, knocking off Councilman Philip A. VanAntwerp and former Sheriff Peter A. Buback in the primary Aug. 6.

McCarthy, Plymouth Township justice of the peace, who stayed out of the race for district judge, polled 18,865 to win his primary.

There are indications the race could be closer with Wayne County

suburbs following the conservative and Republican trends outside of Detroit.

Buback, first appointed to the job in 1963, ran into a ticket-fixing scandal and inherited a shaky administration, He retired July 1 in the face of a state ouster hearing.

"Now I know that the people approve of what I'm trying to dorejuvenate this department, emphasizing professional law enforcement," Gribbs said after the primary.

Shortly before the election, Gribbs called in Detroit and State Police to raid a smoker in Detroit attended by five of his deputies.
