In early December 1986, Mester overturned Farmington District Judge Michael Hand's ruling disallowing testimony by Sharon Vermeulen. Attorney Dana Wilson, Vermeulen's then court-appointed attorney, filed an interlocutory appeal with the Michigan Court of Appeals, which overturned Mester's decision in August 1987. The Oakland County prosecutor then appealed to the Michigan Supreme Court in November 1987.

As follow-up material, Warner's core group developed a resource guide of movies, videos and filmstrips available through the Farmington District Media Center and Oakland Intermediate Schools, about substance abuse.
