### Tour reinforces our concerns

TOUR of Boys Republic last week showed that the temporary home for delinquent boys in Farmington Hills is defluitely more secure than in the past.

But the hourlong visit also reinforced our duspicions about the medium-secure facility for

suspicions about the medium-secure facility for 'wards of the state.

Farmington Hills leaders have asked officials of the private, non-profit, social service agency to describe campus changes and answer queries at the city council meeting next Monday. 1: But that exchange is way overdue. City leaders knew about the changes in March. They must be held accountable for not delving into them sooner.

Their lack of oversight has fueled the rumor mill. Neighbors, hearing about fenced baskeball courts, locked bedrooms and 24-hour audio monitoring, fear hard-core felons have invaded their quiet neighborhood at Nine Mile and Inkster.

"THERE'S A clear need for facilities like Boys Republic to give wayward kids another chance to turn around their lives. Farmington Hills isn't furning its back on that civic responsibility.

"But the community has a right to know who's housed at Boys Republic. It's as simple as that.

"Heck, it wasn't until last week the public Jearned that Boys Republic no longer houses only boys from broken homes and who are guilty of nothing more than petty crimes.

It was learned the campus also is home to some boys who have committed more than one serious crime: burglary, car theft, drug possession."

rector, and state officials stress that no violent criminals would ever be housed in Farmington Hills.

WE HAVE no reason to doubt them. The treatment program has evolved over the past 15 years but it hasn't endangered the community. But we're still uneasy about boys in the assessment program.

But we're still uneasy about boys in the assessment program.

The assessment program, in combination with increased staff and renovated housing units, has yielded tighter security, in turn, curtailing truency and making the neighborhood safer, campus officials say.

In exchange for improving campus security, the state, strapped for beds for delinquents, will continue to send more boys to Boys Republic. As part of a one-year agreement, the campus will receive a higher daily payback, which will help pay off a \$1 million mortgage taken for security improvements.

Instead of being placed there by the state after assessment, boys in the new program still must be assessed before the state places them for long-term treatment.

long-term treatment.

Boys Republic can refuse a boy for the assessment program or can seek reassignment of trouble-makers.

ble-makers.
State officials say their pre-assessment screening of each boy and his family — and their assurance no boy sent to Boys Republic requires maximum security — should negate any fears that the assessment program is a greater risk to the community than the treatment program. We're openminded about the assessment program because the need for beds for delinquents is critical. But it's still a new use of the land — subject to zoning board approval.

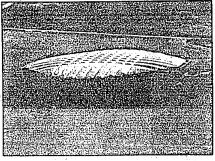

FOR YEARS the taxpayers of Michigan have been forced to subsidize this business to the tune of \$800,000 annually. Initially, many supported the concept with good reason. Pontiac was a struggling city. The Silverdome, it was argued, would attract new businesses, create jobs and bring a renewed prosperity to the area. But none of that has happened. Although Oakland County has experienced a breath-taking economic expansion, Pontiac still struggles. And the area around the Silverdome is barren. To add insuit to injury, struggling Pontiac residents have been forced to fork over \$1.2 million a year to support what has become the white elephant of arena's in the Detroit area.

And that \$1.2 million would go a long way in helping out a city badly in need of more cash. Silverdome officials claim that increased

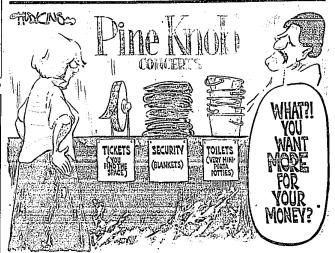

# Red flags are marring plans for peace march

SKEPTICS HAVE challenged his motives, partly because of uncertainty about his credentials. But growing support for his planned peace march and rally on Stunday, Oct. 15 in Farmington has relinforced his resolve.

"We're on the move. I don't think we can be stopped. I feel like a dam has broken," says Derwin Success, a lay staff member at Berea-St. Paul's United Methodist Church in Highland Park and the sparkplug behind the new community coalition, Love Force United.

A political opportunist he's not. That's why Success, a black member of a biracial family victimized by racial slurs in their Farmington neighborhood, opted out of the city council race after considering it. He didn't want politics contaminating his real dream: promoting racial nurrest.

ON MONDAY, the Farmington City Council gave his group the green light to meet on the lawn and steps of the city hall immediately af-ter the march to hold a peaceful rai-ly in support of ethnic unity.

Parade permits require that the state be released of liability. So first Love Force United must tine up a \$1-million insurance policy protection the city from any damage claims arising from the march.

Still, the city's conditional support dovertails with the 73 people, at Love Force United's first meeting on Aug. 14, who "apoke from their hearts" against racism, Success said.

"We need to do more than just wave a flag. We need people. We need to be a shining light. We no longer can tolerate racism. We need a show of unity."

SUCCESS, HIS wife, Dianna, and their two young children have been targets of hate messages since mov-ing to their home on Shiawassee four years ago. Dianna and the kids are

white.
Two days before Christmas in 1887, vandals spray-painted "Get Out Nigger" and "KKK" on the brick and stiding of his well-kept borne.
When racial taunts picked up this summer, Success installed a tall stockade fence around his back yard to make his home and his family

to make his home and his family more secure.

Success has a right to live in peace, But I'm concerned that he calls himself a reverend and says he has a doctorate when he's not ordained and his highest degree is a master's I also don't understand his distrust of the Farmington police, who have stepped up patrolis near his house and will aggressively prosecute anyone caught harassing him.

A peace march and rally should go a long way toward breaking down racial barriers. But for the event to succeed, Derwin Success can't keep
